OFFICIAL RULES

These are the Official Rules of the Utah Golden Owl Award® Contest (“Contest”). The Contest is co-sponsored by the Utah FFA Foundation, 2300 Old Main Hill, Logan, Utah 84322; and Nationwide Mutual Insurance Company (“Sponsors”), One Nationwide Plaza, Columbus, Ohio 43215.

NO PURCHASE IS NECESSARY TO ENTER OR WIN.

A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

ELIGIBILITY

Nominees must be Utah-licensed educators currently teaching agricultural education courses at the secondary (middle/high school).

TEACHERS MAY NOT SELF-NOMINATE. Nominations can be submitted by the general public, current or former students, parents, fellow educators, school administrators and community members.

Employees, affiliates, subsidiaries, advertising and promotion agencies, and any entity involved in the development, production, implementation, administration or fulfillment of the Contest (all of the foregoing, together with Nationwide, and Utah FFA collectively referred to as "Promotion Entities") and their immediate family members and/or those living in the same household of such persons, whether related or not, are not eligible to enter the Contest.

HOW TO ENTER

The Nomination period begins **October 1, 2025 and ends December 15, 2025 at 11:59 p.m. MST** (“Nomination Period”).

Entry constitutes consent to participate in the Contest and for Utah FFA Foundation to obtain, use, and transfer the entrant’s name, address and other details for Contest administration purposes. The Utah FFA Foundation will not be responsible for lost, incomplete, illegible, late, misdirected, stolen, or mutilated entries; technical or mechanical malfunctions; errors in the Official Rules, in any related ads or materials; or processing error. The Utah FFA Foundation can void the entry of any Entrant who it believes has attempted to tamper with or impair Contest administration, security, fairness, or proper play.

HONOREE DETERMINATION

Five (5) Honorees will be selected by an established committee.

Nominations will be judged based on the following criteria:

1. Teacher’s dedication to agriculture education
2. Teacher’s commitment to his/her student(s)
3. Teacher’s impact on his/her student(s)
4. Teacher’s impact on their local community
5. Teacher’s impact on the agriculture industry
6. Number of nominations for the teacher

In the event of a tie, the teacher receiving the highest number of nominations shall be selected as Honoree.

The five (5) Honorees will be selected by January 15, 2026. The five (5) Honorees will be notified and announced by January 31, 2026.

GRAND PRIZE WINNER DETERMINATION

The five (5) Honorees will complete a supplemental nomination form, one of whom will be chosen as the overall State winner. This completed form will be due by February 15, 2026.

The committee will review supplemental nomination forms and select the winner. At the 2026 Utah FFA State Convention held March 12-13, 2026 in Logan, Utah the new Utah Agricultural Educator of the Year will be announced.

If a prize winner is not eligible to win, or if Utah FFA Foundation is unable to contact the winner after a reasonable effort, the prize will be forfeited, and an alternate winner may be selected. Odds of winning depend on the number of eligible entries received.

SPONSORS ARE NOT RESPONSIBLE FOR TRAVEL-RELATED EXPENSES ASSOCIATED WITH PRIZE ACCEPTANCE.

PRIZES

Prizes will be awarded as follows:

1. One (1) Grand Prize Winner: Trophy and \$3,000 cash prize
2. Five (5) Honorees: Plaque and \$500 cash prize

Prizes are non-transferable, and no substitution will be made except as provided herein at the Sponsors' sole discretion. Sponsors reserve the right to substitute a prize for one of equal or greater value if the designated prize should become unavailable for any reason. Winners are responsible for all taxes and fees associated with prize receipt and/or use.

If requested, winners must execute and return an Affidavit of Eligibility, Liability Release and (where legal) Publicity Release within three days of notification. Failure to do so may result in disqualification, forfeiture, or award to alternate winner.
